TEPP's Mission

TEPP's mission is to ensure that federal, state, tribal, and local responders have access to the plans, training, and technical assistance necessary to safely, efficiently, and effectively respond to transportation accidents involving DOE-owned radioactive materials. To accomplish this mission, a suite of tools have been developed to aid the response jurisdictions in their readiness activities.



YTD 2022 National Training Activities

Completed training sessions and headcount in YTD 2022 by Regional Government Group

- ✓ <u>Western</u> 17 classes by DOE and 68 by state instructors with 279 students
 attending
- ✓ <u>Midwest</u> 1 class by DOE and 2 by state instructors with 34 students attending
- ✓ Northeast 11 classes by DOE and 0 by state instructors with 201 students attending
- ✓ <u>Southern</u> 35 classes by DOE and 1 by state instructors with 549 students attending


- Online MERRTT Refresher Training

TEPP continues to work with the National Fire Protection Association (NFPA) through the Technical Committee on Hazardous Materials Response Personnel









- Integrates NFPA 472, 473, and 1072 into a single standard
- Consolidates and unify NFPA standards with similar content
- Goal is to increase usability, reduce errors and conflicts, and ultimately produce higher quality standards
