

#### **Agency Cooperation**

- TEPP continues to work with the National Fire Protection Association (NFPA) on Standard 470 Hazardous Materials/Weapons of Mass Destruction (WMD) Standard for Responders
- TEPP continues to use CBRNResponder in advanced level classes
